At a meeting of the Council held in the Council Chambers on Tuesday 26th April 2022.

483. Apologies

All members of the Council were present at the meeting.

484. Declaration of Interests

Cllr. B Lamb declared an interest in the Bere Ferrers Villagers Group.

485. Notifications of items of interest as the discretion of the chair. No action can be taken on these items.

Cllr. Dennis reported that on arrival at the Parish Hall that morning, there was debris and two wooden panels around the entrance and three large balls on the roof. Cllr. Dennis cleared up the area and the Workman retrieved the balls. Three youths, requesting the return of the balls, were asked to attend the Council Chambers that evening, to make arrangements with the Clerk to have the balls returned.

Cllr. Lamb wished that the continuing issue of the local housing crisis be put on the next Council's agenda and that the Council discuss a plan of action, to work alongside West Devon Borough Council. Cllr. Crozier provided further information on the housing situation in the area and that West Devon Borough Council is keen to build more houses, in partnership with Livewest, but land was required to build theses houses on.

Cllr. Lamb discussed the idea of the Councillors conducting a workshop to discuss any changes required or recommendations for the Council, which should be undertaken sometime this year.

Cllr. King asked, on behalf of the Carnival Committee, if the Council would consider having a float in the carnival this year. The theme is Music of the Reign and Carnival week will start on 28th May.

486. Chair's Report

Cllr. Crozier detailed the recent incidents of vandalism and anti-social behaviour and evidence of drug use in Bere Alston. All incidents have been reported to the Police. The vandalism in the toilets resulted in them being closed at 3 pm. A meeting with the local Police Community Support Officer with the Chair, Vice Chair, the Clerk and members of staff is to take place at the Council Chambers on Friday 29th April to discuss the issues in the village.

The opening ceremony for the new zip wire installed at the Bere Ferrers recreational field, will be on Sunday 22nd May at 2.30 pm and all members are welcome to attend.

The new water pipe at the Bere Alston recreational field has been installed. Other works, including improvements to the dog field entrance have also been completed.

<u>Minute 470</u>	A Community Wellbeing event is taking place in the Bere Alston Parish Hall, $2-5$ pm on Tuesday 17 May. Dennis confirmed with the members of the Council that 3 years ago Beregen was in poor financial state and the Chair of Beregen asked the Council to take on contract, until they were financially viable again.
- <u>Minute 480</u> Due to recent vandalism, the toilets were being closed early and it had solved the issue. The opening hours will go back to normal, but if further incidents of vandalism occur, they will be closed early again and notices placed on the gates to indicate why.

Brain Lamb has offered, subject to your approval, to manage the event on behalf of the Parish Council and thereby ensuring that it complies with all safety and insurance requirements, including of first aid.

We will of course assist Brian, staffing a during all the events, including supervisors within the actual Play Park with the new Zip wire.

Cllr. Lamb proposed the Council act as the organiser for this event, seconded by Cllr. Maycock.

3. The Clerk read out a letter from the Secretary of the Carnival Committee detailing the proposed schedule for the Carnival week beginning with the Carnival parade on Saturday 28th May 2022, Quiz night on Thursday 2nd June and finishing with the Fun Day on Saturday 4th June 2022. They also request permission to use the recreational field for the congregating and judging of floats and will respect the wishes of the council to keep large vehicles and trailers away from the sensitive grass areas, especially during wet weather. Also, we would request that we can have use of the toilet's facilities at the football pitch during this time too.

It was discussed that the Football Club would also need to be informed on the use of the toilet facilities. Cllr. Maciejowska proposed the Council give their permission to use the field, seconded by Cllr. Drury-Graeme.
