- <u>1278/22/VAR</u> Mr Darren Churchill, application for removal of condition 7 (joinery) and variation of condition 2 (approved plans) of planning consent 0060/17/FUL at the Old Workshop 47a Station Road, Bere Alston, PL20 7EN.
- Comment: The Council had no objections to the application.
- <u>1469/22/HHO</u> Ms Isobel Lindsell, application for proposed conversion of domestic store to an annexe for ancillary accommodation with extensions and alternations (Resubmission of 3258/21/HHO) at 42 Cornwall Street, Bere Alston, PL20 7BG

Discussions took place on the building's heritage.

- Comment: The Council support this application, but this is probably the oldest surviving dwelling in Cornwall Street. It is important that its original front facing the road is maintained. It is unique in many aspects of a smallholder's home and working space of the18th century. Now to be a home.
- 4729/21/FUL Miss Ellie Scott Devon and Somerset Fire and Rescue, extension to fire station, new ramp and replacement and relocation of training tower at 49 Station Road, Bere Alston, PL20 7EN
