Matters Arising

Minute 465 (391) The proposed road name change for Station Road, Bere Ferrers, before drafting a letter to residents, the Chair of the Council is to have an informal talk with West Devon Borough Council.

Minute 471 After attending a meeting regarding trees encoarching on the back of the garages by the Parish Hall, Cllr.

Crozier stated that the property owner is willing to deal with the issue. The owner of the garages would also

like the Council to tidy up the debris situated on the land.

Mr Hillson was present at the meeting and gave information to the Committee on the application. No plans have been drawn up yet, but the thoughts are to build a dormer 3-bedroom property.

525. Enforcement cases to be taken into Part Two

Discussions took place with regards to enforcement cases.

526. 20 mph expression of Interest Tranche 2 - Supporting information required

The Devon County Council Traffic Orders, Policy & Programme Team, have requested more information on the extent of the Council's requested 20mph areas and ask a map be submitted outlining the roads that the Council wish to be included. Cllr. Crozier advised that all roads in both Bere Ferrers and Bere Alston that are currently 30 mph, be changed to 20 mph should be submitted.

Cllr. Lamb proposed the Cllr. Crozier and the Clerk mark out on a map for each village, the proposed 20 mph areas and submit to Devon County Council, Seconded by Cllr. Maciekjowska.

527. Approve the Neighbourhood Plans' funds to transferred to the Council and place in an earmarked reserve, for spend by the Neighbourhood plan only

No funds have been added to the Neighbourhood Plans bank account for a few years, but are being charged a monthly admin free of £5, therefore depleting the funds. There is currently approx. £441 in the account and the group have suggested these funds be donated to the Council and earmarked for future spend by the Neighbourhood Plan project only. Cllr. Maycock proposed this recommendation be put forward to the F & G.P Committee for their approval. Seconded by Cllr. Lamb.

528. Requisition from the Land Registry in regards to the registration of the Parish Hall

The Council has received correspondence from the land Registry requesting more information on the rights the Council have for the use of four parking spaces in the Doctor Surgery's car park. Cllr. Lamb proposed he look for the documentation in the Council's offices and in the meantime the Clerk to send an acknowledgement email to the Land Registry.

529. Devon Highways & Grit Bins updates

All empty grit bins have been reported to Devon Highways.

In response to Devon Highways refusal to add The Down to the gritting route, Cllr. Lamb has drafted a letter to the Chief Executive of Devon County Council, outlining how the Council feel Devon Highways neglect the Bere Peninsula and continually turn down the Council's various requests for improvements to the roads within the Parish. After discussions it was proposed that, after certain information was sent to Cllr. Lamb by the Clerk, the letter be sent and signed by either the Chair or the Vice-Chair of the Council. All members were in agreement.
