82. Apologies

No apologies were received.

83. Declaration of Interest

Cllr. Grose declared an interest in the item, Inspection of Allotments.

84. Notification of items for information at the discretion of the Chairman. No action can be taken on these items.

Cllr. Wager brought up the issue of a dead ash tree near Weir Quay and Holes. It is on Mount Edgecumbe land and the Clerk to report.

Cllr. Grose – Cattle will be going into that field that footpath 95 runs through and the landowner has made a request to Public Right of Ways, to install three self-closing gates

Cllr. Leithall – the swinging chair in the Bere Ferrers recreational field is missing a ground screw. The Clerk to ask the Workman to install a longer screw.

85. Matters Arising from the minutes from the meeting held on 11th April 2023

The minutes were adopted and approved at a Council meeting held on Tuesday 30th April 2023

Matters Arising

Minute 606 (538) The Pizza Van have asked permission to trade in the Bere Alston carpark on Sunday 18th June. The

Committee had no objection. Charges to trade in the car park after their trial period, will be discussed

under item 87.

Minute 609 The notice informing residents of the Council's plans to tidy up the Memorial Garden has been taken

down and the work is due to start shortly.

Minute 610 The Wildflower Group have confirmed, via the Clerk, that the crab apples will be left in their current

position.

Minute 612 The Clerk reported to the Chair of the Bere Ferrers Villagers Group that a bolt was missing from a

piece of play equipment, but they could not find it. The Clerk to clarify with the Workman what piece

of equipment is missing a bolt and pass back to the Group's Chair.

86. Detailed Receipt and Payment report for 2022-23

It was note that the fee paid by the annual rent paid by the Bere Alston Football Club is short by £40. The Clerk to look into it.

Cllr. Grose queried the cost of allotments at Bere Ferrers. The Clerk confirmed that all, except the Orchard and two plot which have been split into two, are £16 each.

The Clerk explained that under Cemeteries, Code 4990, Sundries, the £301 was a repayment to a Funeral Director, who had paid this amount to the Council in error.

The Committee accepted the report.

87. Recreation Grounds & Open Spaces Conditions of Use and Hire Policy. To be taken into Part 2

Cllr. King proposed going into Part 2, seconded by Cllr. Leithall.

Cllr. Leithall proposed coming out of Part 2, seconded by Cllr. King.

Cllr. Pengelly proposed for the hire of part of the recreational fields (approx. size of Junior football area) be £13 per hour. The hire excludes the fenced off football pitch. Seconded by Wager. All for, except one who abstained.

For commercial businesses using the recreational field car parks, Cllr. Crozier proposed a rate of £15 an hour. Seconded Cllr. Wager. All for, except one who abstained. It was recommended that charges to come into effect from 1st July 2023.

All members agreed that not for profit charitable organizations and events, the hiring of Recreational Field & Open Spaces will be free of charge.

These recommendations to be discussed at the F & G.P Committee meeting on 20th June 2023 and final approval given at the Council meeting on 27th June 2023.
