490. Apologies

An apology was received from Cllr. Wager. The Council accepted his apology.

491. Declaration of Interests

None were given.

492. Notifications of items of interest as the discretion of the chair. No action can be taken on these items.

Cllr. Crozier spoke on the closure of Denham Bridge due to vehicle damage and that this is completely out the Parish Council's hands, but the Council should express their support to Devon Highway to get the repairs completed and the bridge reopened as soon as possible. At present there is no estimate on when the bridge will be reopened. The Clerk to contact the Local Devon Highways Officer and request updates be forwarded on, in order they can be passed onto residents.

Cllr. Dennis met with representatives from Voneus Broadland and discussed their upcoming project to bring full fibre broadband to Bere Alston.

493. Representatives from South WestWater and Keir; to discuss planned improvements and upgrade to Sewer treatment works to the west of the village

A Representative from South West Water and Keir spoke in regards to works that will commence on May 2024, which will make improvements and upgrade the Sewer Treatment works to the west of Bere Alston.

The construction traffic will access the site by two routes, one to the north and one to the south of the village Each route will avoid the centre of the village and not be used during peak traffic times. Construction vehicles will be staggered between each route and at present there is no estimate on the number of vehicles movement each day. Each proposed route was discussed and South West Water and Keir took on board the Parish Council's feedback on their planned routes.

There are two planned roads closure:

- Pentillie Road for vegetation clearing and although a traffic road closure notice has been advised for 3 days, it is likely that the road will only be closed for 1 day. The diversion route advertised has been proposed by Devon Highways.
- 2. Lockeridge Road a letter has been delivered to houses at the end of the road, stating there will still be access residents.

The works will carry on for approx. a year and all footpaths will be accessible at all times.

494. Chair's Report

The Co-Op application will be discussed at a West Devon Borough Council Committee Meeting on 27th February 2024. As Chair of the Council, Cllr. Crozier wrote to the Head of Devon Highways, approx. 16 days ago and have not yet had an acknowledgement.

495. To receive reports from the District Councillors

West Devon Borough Council have released their budget consultation for their recommendation 2024-25 budget.

Cllr. Saxby is in the process of setting up a meeting with West Devon to discuss the installation of electric car charging points in Pilgrim Drive. It is likely they will be installed at the end of the year.

A revised application from Zip World has been submitted for Gulworthy and Cllr. Saxby will forward on the application number; in order this Parish can review and submit their opinion.

The Co-Op Survey's results conducted in Bere Alston by Cllr. Saxby has been submitted to the West Devon Planning Department and will forward on the results to the Parish Council.

Nominations for this year's Mayoral Awards are now open. The awards are given out each year to an individual, firm or organisation who have done something particularly noteworthy in the Borough, has enhanced the reputation of the Borough, or made a significant contribution to the conservation and protection of the natural environment of West Devon. If you wish to nominate someone you can do so via the West Devon website.

503. Update on the Co-Op planning application (2215/22/FUL)

The Co-op planning application will be discussed at the West Devon Committee meeting on 27th February 2024. The Parish Council are requesting two major points:

- The 30-mph speed limit be relocated to Quarry Cross. This is because the pedestrian road cross for will be in the 60-mph zone and due to lack of lighting it will be very difficult for drivers to see people crossing. The crossing will also not be marked. The Co-Op have offered to pay for the relocation of the speed limit. Devon Highways have agreed to the reduced speed limit to 30 mph on Woolacombe Road, but not the B3257.
- 2. The Co-Op and Devon Highways need to arrange for the local bus to stop at the store, therefore the Parish will be asking that a bus stop is put in as a planning consider.

504. Report from the Sports Development Committee, Open Public Meeting, 17th February 2024

The event on 17th February 2024 is progressing and there has been a good response from Sports organisations. The Neighbour Plan group will also be attending. The event has been advertised in Berelink and will be advertised in the Tavistock Times, social media and posters around the village.

505. Open Spaces committee recommendation to expand the Bere Alston recreational field play park

Following a recommendation from the Open Spaces committee, Cllr. Pengelly proposed the extension of the playpark by approx. 180 square metres, seconded by Cllr. Maciejowska. All in favour. The extension would not impact on the junior football pitch
