#### 508. Apologies

There were no apologies.

### 509. Declaration of Matters of Interest

# 511. Discussion from Stagecoach South West Operators Manager regarding incidents of parked cars causing issues to bus routes

Three members of South West Stagecoach were present at the meeting to highlight the ongoing issue of parked cars blocking the bus route around Bere Alston, causing either major delays, or the route having to be abandoned all together. Stagecoach are in daily contact with Devon County Council with regards to this issue and when buses are unable to pass, the Police are having to be called.

The main problem areas are:

Edgcumbe Arms – cars parking causing issues for the busses passing along and lorries delivering having to park on the bus stop, due to cars parking in the loading bay.

Whitehall Road - buses unable to pass parked cars

Pounds Park Road – badly parked cars, resulting in the bus drivers having to mount the kerb at time to get past.

Lockeridge Road – awardkly parked cars making it different to pass.

After discussions, the Council agreed to write a letter to local residents highlighting the issue and also post issue on social media. Stagecoach were also invited to attend the Public Consultation Day on 17<sup>th</sup> February 2024 in order to talk to residents They will confirm whether a representative from Stagecoach could attend the event. The Council will also look into producing a leaflet that can be left on cars to highlight they have blocked the route.

A possible outcome, if the bus routes continue to be delayed or abandoned, is Devon County Council may decide to install double yellow lines along Fore Street. This was proposed a few years ago, as Gritters complained they were unable to get through, but the Parish Council managed to persuaded them not to do, their argument being buses could get through.

The Council asked Stagecoach to keep logging and photographing (if able to), all incidents, including abusive behaviour towards the bus drivers, keep reporting all incidents to Police and regularly update the Parish Council on all incidents, in order they can either follow up with residents or the Police.

#### 512. Matters arising from minutes at the meeting held on 9th January 2024

# 513. To deal with Planning applications for comment. Interested parties are invited to comment on applications they have an interest in before a decision is made, at the discretion of the Chair.

<u>0111/24/HRN</u> Devon Grown Ltd, Riverview, Hewton, Bere Alston, PL20 7BW Application for hedgerow removal notice to remove 5 metres of hedgerow to create a second entrance to the property to enable a one-way vehicle flow system.

The applicant's covering letter stated that the current combined entrance/exit for the site serves three holiday let cottages and a residence and they therefore wished to create a new opening by removing 5 metres of hedgerow to create and separate entrance and exit.

After discussions, a vote was taken on whether to support the application. None were for, six were against and one abstain. The Council therefore object to this application.

- Comment: The Council object to the application. There is not enough evidence to justify two entrances and a one-way system could be achieve with current access used.

The Council is commenting on this application as a neighbouring Parish and after discussions a vote was taken. Four were for the application and three against.

Comment: The Bere Ferrers Parish Council after discussion on the application and after a vote, were for the application, but do have environmental concerns.

#### 517. Update on Co-Op planning application (2215/22/FUL)

The Co-Op application is due to be discussed at a West Devon Borough Council Committee Meeting on 27th February 2024. The Clerk will put in a request for Cllr. Lamb to represent and speak at the meeting on behalf of the Parish Council. it was also agreed that a formal request be made for the West Devon Committee to have a site visit of the proposed Co-Op site.

### 518. Update on correspondence between the Parish Council and the Cabinet Member for highways Management Devon County Council

A letter written to the Cabinet Member for Highways Management Devon County Council was sent and a reply was received on 31st January 2024. The reply completely missed the point of original letter. Cllr. Sanders has advised the Parish Council to put in a request to West Devon Borough Council to produce a 106 order that the offer by the Developer for road improvements and the reduction of the speed limit 30 mph, is incorporated into the 106 agreement.

#### 519. Discuss location for grit bin in Tuckermarsh

After discussions it was agreed to leave the grit bin where it currently is located. The Clerk to advise Devon Highways.
