Cllr. King enquired about the forthcoming road closure signs on the B3257 road. Will the whole road is closed during the works duration? The Clerk to request clarification from Devon Highways.

Cllr. Pengelly to visit the Bere Aston Primary School at the end of the school day on Friday 15<sup>th</sup> March, to speak to parents regarding the playpark improvements in Bere Alston. Cllrs. Grose and Lamb to attend also.

Cllr. Lamb update the Committee that the Sport Development Consultation completed forms box will be opened in the Council office on Monday 18<sup>th</sup> March. The information will then collated into a full report.

#### **Matters Arising**

Minute 542 (462) The Clerk read out a reply from the Asset Principal Estates Surveyor at West Devon Borough

Council, who apologised for the delay but confirmed, as previous stated, that WDBC is provisionally supportive of the Council's proposal to turn the piece of land on Pilgrim Drive into additional car parking, They have commissioned a report on title of the land and it is now hoped

that things will progress fairly rapidly.

Minute 544 The Clerk stated that more research was required into the digital cemetery mapping for High Cross

Cemetery and therefore suggested this item be put on hold and brought back to the Committee later

in the year.

Minute 546 Allotment holders will be notified in their 2024 invoice, of the rent increase from April 2025. Invoices

to be sent out from 27th March 2024.

# 601. Open Spaces Receipts and Payments Report ending 29th February 2024

After review all members agreed to accept the report.

### 602. Review quotes for work to be carried out at the Bere Ferrers recreational field car park

The cost for the works required at the car park will be approx. £1200-1300. The committee recommended authorising and final approval will be discussed at the next F & G.P meeting.

#### 603. The Down football parking

Cllr. Shaw has received complaints from residents living on the Down that cars are parking inconsiderately on football day matches. The Clerk had already contacted the Junior football Manager and raised this subject. It was discussed that there is no parking restrictions on the road and the Council can only go back to the Football Club and ask again that they pass on the message that drivers need to be more considerate on where they park.

#### 604. Discuss submitting a grant to fund purchase of Swift boxes and callers

A member of the public at the meeting discussed with the Committee how Swifts are in danger and wished to apply for a small grant to purchase 6 Swift boxes and callers to be placed on 6 properties around Bere Alston. Would the Council submit the grant on their behalf? After a short discussion all members agreed to submit the application.

#### 605. Routine safety inspection reports for the Parish Recreation and Play areas

Cllr. Shaw reported at The Down play park, the bin by the entrance has a slat missing and a nail is protruding from the top of it. Also the wooden fence needs attention. At Sarah Park play park, one post needs replacing. The Workman to action. It was again discuss to bulk buy wooden posts and rails.

There were no issues to report at the Bere Ferrers playpark.

### 606. Report on Parish Councils' policies on poultry on allotments

It was agreed at the last meeting to take advice, before agreeing whether to charge an additional surcharge for poultry owners. After discussions Cllr. King proposed from April 2025, the following allotment charges:

£26 for a full plot and £30 for a full plot with poultry £18 for a half plot and £24 for a half plot with poultry. Seconded by Cllr. Wager. All in favour.

All allotment holders will be notified of the increase in their 2024-25 invoice letter.

#### 607. Inspection of Allotments Bere Alston and Bere Ferrers

Cllr. Crozier reported no major issues at the Bere Alston site. Several vacant plots will be offered to the those currently on the waiting list.
